Amendment arising from RPA Compliance Inspection on 23 Nov 2004

1) H1 areas

Net areas of two H1 fields have been reduced due to ineligible areas identified in the compliance Field Inspection Report – field summary sheet (at Doc. 86 wallet). AESIS has been amended, Schedule 3 amended (on DMS), Table 2.3 amended (on disk – file name = Nettlebed revised 26jan2005).

Field 7745: reduced from 1.77 ha to 1.57 ha – strip of scrub and bracken along road, clearly not managed as part of hay meadow.

Field 5960: reduced from 3.98 ha to 3.11 ha – area occupied by B481 road which crosses field.

A recovery needs to be made for these ineligible areas since the start of the agreement, i.e. since 1995. NB the calculation for the recovery must take account of the changes in payment rate for H1 during the course of the agreement.

2) LH1, LH2 areas

Net areas of most fields under LH1 and LH2 have been reduced following the Compliance Inspection because the area identifiable as open heathland is much lower than the 39.59 ha that was anticipated by this stage of the agreement. The Compliance Inspection measured the total area eligible for LH1 and LH2 as 11.37 ha.

A decision has been made not to recover any payment on this for previous years – see letter to Nigel Phillips at Doc. 88. AESIS, Schedule 3 (on DMS) and Table 2.2 (on disk) have been amended from 2003/04 onwards.

3) F areas

Net areas of fields 4128 and 4214 have been reduced following the Compliance Inspection because the area identifiable as fen/willow carr has been measured as 3.07 ha after areas occupied by mature oak woodland are excluded.

However no recovery should be made because work has been done over the years of the agreement to carry out water retention works thereby improving the fenland habitat for wildlife. AESIS, Schedule 3 (on DMS) and Table 2.5 (on disk) have been amended from 2003/04 onwards.

4) AE grant

Schedule 3 has been amended to show the new payment rate (on DMS).

Revised schedules are in plastic wallet at Doc. 89, but these have not yet been sent to Agreement Holder because the site has not yet been RLR'd which might result in further area changes.

Please process the recovery for H1 payments as per above. Then return file to Alison Muldal to process the outstanding 2003/04 claim.
